



“Team Up with The ONE and Win Sweepstakes”! Official Rules

NO PURCHASE OR TRANSACTION NECESSARY TO ENTER OR WIN and will not increase your chances of winning.

Eligibility: CommonWealth One Federal Credit Union’s “Team Up with The ONE and Win Sweepstakes” is open to all legal residents of the United States who are 18 years of age or older at the time of entry. Employees of CommonWealth One Federal Credit Union and their immediate families (spouse, parents, children and siblings, and their respective spouses) and individuals living in the same households of such employees are ineligible. Void where prohibited by law. Prizes subject to all applicable federal, state and local laws and regulations. All winners agree to these official rules.

Entry: Sweepstakes begins at 12:01 am on October 30, 2017 and ends at 11:59 pm on January 31, 2018 and is subject to change or termination at any time.

This referral form/entry card or a post-season entry form is only available at CommonWealth One Federal Credit Union offices, online at www.teamupandwin.org or www.cofcu.org. Membership eligibility and minimum \$5 deposit required to open an account. Every member who gets a new loan, refinances a loan, or uses bill pay with our Mobile App or online banking is eligible. Qualifications apply. Closed accounts reopened during this promotion are not eligible. Must be first account with CommonWealth One. A joint owner added to an existing account is not considered a new member and does not qualify.

Enter by mail: To enter the Sweepstakes without opening an account at CommonWealth One Federal Credit Union, you may send your contest entry in an envelope to: “Team Up with The ONE and Win Sweepstakes,” CommonWealth One Federal Credit Union, Attn: Marketing, P.O. Box 9997, Alexandria, VA 22304. On the postcard, print your name, address and home phone number. Entry must be postmarked and received by January 31, 2018. Each mail-in entry will count as one (1) entry into the drawing. Entries that are mechanically reproduced, copied, illegible, incomplete, or inaccurate and entries by any means which subvert the entry process are void. Entries become the property of the Sponsor and will not be acknowledged or returned. Entries that are incomplete, late, lost, postage-due, mutilated, illegible or contain irregular or invalid information, or are corrupted in any way are void and will not be eligible.

Sweepstakes drawing: A random drawing will be conducted on February 1, 2018, by CommonWealth One Federal Credit Union from all eligible entries to award the cash prizes. One (1) \$700 winner and three (3) \$300 winners will be chosen. The odds of winning depend on the total number of eligible entries received.

Prize: One (1) \$700 and three (3) \$300 prizes will be awarded in the form of a deposit into the member’s CommonWealth One savings account or will be paid as a cash equivalent on or about February 2, 2018. No substitutions or transfer of prize permitted. CommonWealth One Federal Credit Union will send the winner a 1099-MISC which will represent the value of winning this sweepstakes. Any state or federal taxes that may be owed on prize winnings are the sole responsibility of the individual winner. The odds of winning depend upon the number of eligible entries received; i.e., if 1,000,000 entries are received the odds of winning are 1:1,000,000.

Notification: Winners will be notified by email, postal mail and/or phone. Winners will be required to provide identification, sign an affidavit of eligibility and a publicity release or the prize will be forfeited and awarded to an alternate winner. If CommonWealth One Federal Credit Union is unable to contact



the potential winner within seven (7) days of the drawing, the prize will be forfeited and awarded to an alternate winner. This process will continue until prize is awarded. Acceptance of prize constitutes winner’s permission to use his/her name and photo/likeness for advertising and promotional purposes for this and similar promotions, and in perpetuity in any media, now known or hereafter devised without additional compensation, except where prohibited by law.
